- You must be a Berkshire Hathaway Shareholder
- Shareholders are entitled to a maximum of 4 meeting credentials
- Proxy materials (annual report, proxy statement, and annual meeting credential order form) will be mailed to certain shareholders in mid-March. Other shareholders will be mailed a “**Notice**” instead of a full printed set of materials in mid-March. The **Notice** will provide instructions on how to view the annual report, proxy statement and annual meeting credential order form online. Any shareholder receiving the **Notice** can request a full set of printed materials.

*The meeting credentials are required for entry to not only the annual meeting and other related events, but also to receive shareholder discount pricing*
